school educators to give to students as alternate path to college. Mr. Berch gave the Board the current status of this Bill in the legislature.

Mr. Berch also fielded questions from the Board concerning the Glazier and Ironworker Apprenticeship Programs. The Board noted, for the record, that they appreciate having Mr. Berch present at their meetings.
