# **APPLICANT APPEALING DENIAL:**

#### Nicholas Cornelius, Granville, MA – (F-2) Unlimited Journeyperson - Denied

The Board voted to deny due to the fact that the applicant did not submit additional original, notarized statements from employers as to the dates and duties of employment to prove that he has completed the required 8,000 hours of on the job training. The applicant should provide proof of completion of a Massachusetts apprenticeship program or original, notarized letters from previous employers.

# 1. Residential Fire Protection Sprinkler Systems

The Board continued to discuss the ongoing issue of licenses required to install residential fire protection sprinkler systems. The Board reviewed the following documents:

- Regulation Concerning Licensure for Limited Residential Fire Sprinkler Work
- Residential Fire Sprinkler License Draft Legislation NFPA 13D

The Board requested that the Department inform them of the next Plumbing Board meeting date, as they may consider attending to discuss this matter further.

# 2. Trip testing of fire protection sprinkler systems as it relates to Connecticut licensing requirements

The Board continues to discuss their concern regarding the scope of work involved in trip testing a fire protection sprinkler system and what category of fire protection sprinkler work license is required to do this work. Chairperson David Waskowicz provided two letters written by Michael Skurat, one dated February 21, 1990 and one dated March 20, 1990, regarding this topic.

The Board continues to maintain that trip testing a system involves shutting the system down, and therefore, impairing the system. Current state statute requires a fire protection license when doing work on an impaired fire sprinkler system. The Board is of the opinion that adding and clarifying the term "testing" as it relates to current statutes would be beneficial.
