# 7. Work schedule for F-2/F-4 apprentices

The Board reviewed the work schedules for the F-2 and F-4 license categories, which are posted on the Department of Labor website. The Board expressed their concern regarding out-of-state applications being submitted with letters from employers stating dates and duties of employment, which are often not sufficient for the Board to determine if the applicant's experience meets requirements for the State of Connecticut. The Board noted that this work schedule would be helpful to have available to out-of-state applicants to use as a reference when presenting equivalent work experience.

The Board voted unanimously to request a formal work schedule for the F-2 and F-4 license categories from Department of Labor on their letterhead.
