## OLD BUSINESS:

## 1. Residential fire sprinkler systems

 <u>Discussion on proper licensure for the installation of residential fire sprinkler systems</u> The Board reiterated their position that all residential fire sprinkler systems require an (F-1) licensed contractor with (F-2) licensed employees for installation. Richard M. Hurlburt, Director stated that the installation of multipurpose sprinkler systems require dual type (P-1) and (F-1) license holders with (P-2) and (F-2) license types.

#### NEW BUSINESS:

1. New home construction and home improvement contractors requirements regarding automatic fire extinguishing systems

Richard M. Hurlburt, Director provided the Board with the DCP Booklet *The Connecticut Contractor for Home Improvement and New Home Construction* and a copy of the relevant statute. Discussion took place regarding the obligation of new home construction contractors to provide the potential homeowner with a disclosure form containing information on automatic fire extinguishing systems, which states specifically that, "The new home construction contractor, or his agent, shall also discuss with the consumer the installation of an automatic fire extinguisher system in a new home."
