1. Multipurpose Residential Fire Sprinkler Systems

1. Proposed License Types F7/F8 - Multipurpose Residential Fire Sprinkler Contractor/Journeyperson

- Discussion took place regarding the following two areas in relation to the proposed F7/F8 license types regarding the most appropriate term to use, "license" or "certification", and regarding whether or not proof of liability insurance could be required.
 After discussion, Richard Hurlburt clarified that this new category would be a "license" versus "certification." In addition, he also clarified that a liability insurance requirement would have to be implemented legislatively.
- The related instruction requirements for the proposed F7/F8 license are being drafted at this time by board members Robert Hollis and David Waskowicz.
- The proposed code amendment that may occur at this time is drafted as follows:

(Amd) R313-2 One and two family dwellings automatic fire systems. When an automatic fire sprinkler system is to be installed in one and two family dwellings, it shall be designed and installed in accordance with Section P2904 or NFPA 13D.

(Del) R313.1.1 Design and Installation. Delete without substitution.

2. Connecticut General Statutes Section 20-330; Definition of "Fire Protection Sprinkler Systems Work"

Brief discussion took place regarding this statute, as it pertains to inspection and testing. David Waskowicz, Chairperson, was advised to contact other occupational licensing boards for an update on the status a potential change in statutes.

Also, if a licensee owes any money to DCP, for any reason, DCP can take any action against *any* license held, not just the license that the outstanding fees are related to.
