The Board voted to approve the minutes of the May 15, 2014 Heating, Piping, Cooling and Sheet Metal Work Examining Board meeting as written.

APPEARING FOR GUIDANCE:

Christopher Morgan, Rocky Hill, CT

The Board provided Christopher Morgan and Christopher Morgan, Jr. with guidance regarding the requirements and process for licensing.

Vincent N. Amodio, New Haven, CT- Conditional approval for (S-2) Unlimited Journeyperson

The Board voted unanimously to approve Mr. Amodio for the (S-2) examination, contingent upon successfully obtaining universal CFC certification, completing the required cooling courses for the S-2 license type, and the submission of an application acceptable to Department standards. Furthermore, the Board voted unanimously to waive the two-year waiting period after passing the (S-2) examination, so that he may take the (S-1) examination immediately upon passage of the (S-2) examination. Further review by the Board is not needed; the Department may approve at such time that the above-referenced conditions are met.

APPEARING FOR APPEAL:

Pedro Mojica, Groton, CT – (D-2) Limited Journeyperson - Denied

Pedro Mojica was denied at the March 20, 2014 meeting due to lack of apprenticeship completion, on the job training, and related instruction.

Mr. Mojica appeared today to appeal this denial. The Board voted unanimously to deny Mr. Mojica's (D-2) application due to lack of apprenticeship completion and reciprocal New York license.

Dennis Dougherty

Dennis Dougherty appeared to discuss his concerns, as stated in his letter dated February 1, 2014, regarding the Board's decision to approve a waiver of the two-year waiting period for the S-1 license for Kyle Herindeen on December 12, 2013.

Dennis Dougherty stated his concerns and a discussion took place. The Board voted unanimously to refer this matter to DCP Trade Practices Division.

APPEALS:

Saif Kahn, Manchester, CT - (S-2) Unlimited Journeyperson - Denied

Saif Khan was denied on May 15, 2014 due to lack of apprenticeship completion and related instruction. Additional documentation was submitted and the Board reviewed at today's meeting.

The Board voted unanimously to deny Mr. Kahn's (S-2) application due to lack of apprenticeship completion and insufficient documentation regarding required hours of related instruction.

Alex Littman, Bridgewater, MA - (S-1) Unlimited Contractor - Denied

Alex Littman was denied on May 15, 2014 due to lack of the (S-2) Unlimited Journeyperson license for a period of two years.

The Board voted unanimously to deny Mr. Littman's (S-1) application due to lack of additional documentation for the Board's review.

Luis Fernandes, Ridgefield, CT – (SM-2) Limited Journeyperson – Approved The Board voted unanimously to approve Mr. Fernandes' (SM-2) application.

Christopher Frattaroli, Easton, CT – (S-2) Unlimited Journeyperson – Denied The Board voted unanimously to deny Mr. Frattaroli's (S-2) application due to lack of apprenticeship completion and related instruction.

Mr. McGraw, after discussion with the Board, chose to amend the category of license sought from (S-3) to (S-4). The Board then voted unanimously to approve Mr. McGraw for the (S-4) examination. Furthermore, the Board voted unanimously to waive the two-year waiting period, so that he may take the (S-3) examination immediately upon passage of the (S-4) examination.
