#### **APPEARING FOR GUIDANCE:**

#### Donald Aulenti, Stamford, CT – (S-1) Unlimited Contractor

Mr. Aulenti appeared seeking guidance regarding qualifications for the (S-1) Unlimited Contractor license type. He currently holds an (S-3) and a (P-1) license. The Board determined that Mr. Aulenti had been previously approved for the (S-2) examination and advised him to apply and take the (S-2) examination.

## Eric Cosgrove, Stratford, CT – (S-1) Unlimited Contractor

Did not appear; no action taken

Robert J. March, Coventry, CT – (S-1) Unlimited Contractor – Conditionally approved Robert J. March appeared with his father, Robert L. March, to seek a waiver of the two-year waiting period for the (S-1) license due to a hardship. Mr. March has held an (S-2) license since April 2014 and a (B-2) license since 2005. The Board voted unanimously to approve Mr. march for the (S-1) examination contingent upon submission of an application acceptable to DCP standards and submission of a letter to DCP stating that the company's (S-1) holder will be leaving the company and therefore creating a hardship.

#### APPEARING IN PERSON TO APPEAL DENIAL:

# David Owen, Jr., Bridgeport, CT - (S-2) Unlimited Journeyperson - Denied

The Board voted unanimously to deny Mr. Owen's (S-2) application due to lack of apprenticeship completion for the (S-2) license type.

# Thomas Thurlow, Dayville, CT – (D-1) Limited Contractor – Change in category/Approved for D-2

After discussion with the Board, Mr. Thurlow chose to amend the category of license sought from a (D-1) to a (D-2). The Board voted to approve Mr. Thurlow's (D-2) application. The Board also voted unanimously to waive the two-year waiting period so that Mr. Thurlow may apply for the (D-1) examination immediately after passage of the (D-2) examination without further Board approval.

# **Samuel Emert, North Stonington, CT – (S-1) Unlimited Contractor** Did not appear; no action taken.

#### **APPEALS:**

## Joseph Demers, Newtown, CT - (S-7) Limited Contractor - Denied

The Board denied Mr. Demers' (S-7) application at the June 19, 2014 meeting. Mr. Demers has submitted a letter stating that he would be willing to change the license type applied for to an (S-8), and requests that the application and related documentation be reviewed again. The Board voted unanimously to deny Mr. Demers' (S-7) application due to lack of documentation and training. The Board noted that he has been approved for the (S-10) examination, contingent upon receipt of CFC certification, in 2012 and advised that he pursue that direction.

Branden Altman, Port Jarvis, NY – (SM-2) Limited Sheet Metal Journeyperson – Approved The Board voted unanimously to approve Mr. Altman's (SM-2) application.

Nicholas Dahlberg, Brewster, NY – (S-2) Unlimited Journeyperson – Conditionally approved The Board voted unanimously to conditionally approve Mr. Dahlberg's application contingent upon review by DCP to determine if the qualifications submitted are comparable to the scope of work of the Connecticut S-2 license type for on-the-job-training and related instruction.

### Krzysztof Fekieta, West Haven, CT - (S-2) Unlimited Journeyperson - Denied

The Board voted unanimously to deny Mr. Fekieta's (S-2) application due to lack of apprenticeship completion for the (S-2) license type.

### Hersh Fried, Monsey, NY - (D-1) Limited Contractor - Denied

The Board voted unanimously to deny Mr. Fried's (D-1) application due to lack of documentation to determine equivalent experience and training.

# Edward Lent, New Milford, CT – (D-2) Limited Journeyperson - Approved

The Board voted unanimously to approve Mr. Lent's (D-2) application.

Frank Mitarotonda, Mount Vernon, NY – (SM-3) Limited Sheet Metal Contractor - Denied The Board voted unanimously to deny Mr. Mitarotonda's (SM-3) application due to lack of apprenticeship, on-the-job training, and related instruction.

## Christopher Olmstead, Darien, CT - (D-1) Limited Contractor - Denied

The Board voted unanimously to deny Mr. Olmstead's (D-1) application due to lack of a (D-2) license for the required two-year period, lack of apprenticeship, and lack of proof of related instruction.

Michael Rines, Jr., Torrington, CT – (D-2) Limited Journeyperson – Conditionally approved The Board voted unanimously to allow DCP to approve Mr. Rines' (D-2) application contingent upon receipt of apprenticeship completion letter.

### Robert Roccuzzo, Bronx, NY - (D-2) Limited Journeyperson - Denied

The Board voted unanimously to deny Mr. Roccuzzo's (D-2) application due to lack of apprenticeship completion and on-the-job training.

## Jayson Sherwood, Danbury, CT - (S-1) Unlimited Contractor - Denied

The Board voted unanimously to deny Mr. Sherwood's (S-1) application due to lack of apprenticeship completion and related instruction.

Jamie Boss, Jr., Wallingford, CT – (S-2) Unlimited Journeyperson – Conditional approval The Board voted unanimously to approve Mr. Boss for the (S-2) examination contingent upon submission of an application acceptable to DCP standards and submission of letters from employers for proof of on-the-job training and proof of related instruction.

Greg Barnum, Milford, CT – (D-2) Limited Journeyperson – Conditional approval The Board voted unanimously to approve Mr. Barnum for the (D-2) examination contingent upon submission of an application acceptable to DCP standards. Paul Femia, Dept. of Labor, verified that he has completed the apprenticeship program.

Peter Wiese, Jr., Stormville, NY – (S-2) Unlimited Journeyperson – Conditional approval The Board voted unanimously to conditionally approve Mr. Wiese's (S-2) application contingent upon review by DCP to determine if the qualifications submitted are comparable to the scope of work of the Connecticut S-2 license type for on-the-job-training and related instruction

The Board discussed new requirements for pressure testing of new duct systems which will be taking effect soon. It was noted that there was no license or certificate required at this time for this testing. Chairperson Robert Barrieau drafted a document outlining a preliminary course designed

for individuals to increase their knowledge and understanding of effective duct leak testing for review by the Board. Robert Barrieau stated that this proposed course could be a 4 or 8 hour certification course. The Board reviewed this document and requested that this topic be on the October meeting agenda for further discussion.
