APPEARING IN PERSON FOR APPEAL:

Christopher Sanchez, Stonington, CT – (D-2) Limited Journeyperson – Conditional approval

Mr. Sanchez appeared before the Board today. The Board voted unanimously to conditionally approve Mr. Sanchez's (D-2) application, contingent upon submission of application to PSI.

Eugene Hammer, III, Katonah, NY – (S-2) Unlimited Journeyperson - Approved Mr. Hammer appeared before the Board today for appeal of 12/12/13 denial. The Board voted unanimously to approve Mr. Hammer's (S-2) application. The Board further ruled that, upon passage of the (S-2) examination, he be approved to take the (S-1) exam without waiting the two-year period.

The Board voted unanimously to deny Mr. Astacio's application due to lack of apprenticeship completion letter. It was confirmed that Mr. Astacio has completed his apprenticeship. Mr. Astacio should obtain such letter and submit to DCP for Department approval.

Kyle Bridgewater, Avon, CT – (D-4) Limited Journeyperson – Denied

The Board voted unanimously to deny Mr. Bridgewater's application due to lack of apprenticeship, on the job training, and related instruction.

Steven DeFino, Mahopac, NY - (SM-2) Limited Journeyperson - Approved

The Board voted unanimously to approve Mr. DeFino's (SM-2) application.

Ali Gishta, Waterbury, CT – (S-2) Unlimited Journeyperson – Denied

The Board voted unanimously to deny Mr. Gishta's application due to lack of apprenticeship completion letter. It was confirmed that Mr. Gishta has completed his apprenticeship, therefore, his employer should contact the Dept. of Labor to request completion letter.

Anthony O'Sullivan, Trumbull, CT – (S-2) Unlimited Journeyperson – Denied

The Board voted unanimously to deny Mr. O'Sullivan's application due to lack of apprenticeship, on the job training, and related instruction.

The Board voted unanimously to deny Mr. Blanco's application due to lack of apprenticeship and on the job training.

The Board voted unanimously to deny Mr. Fournier's application. The Board noted that the Connecticut license type B-2 is the license type most closely related to Mr. Fournier's Massachusetts license, therefore, he may opt to change the license type on the application to a B-2 and return to the Board for reconsideration.

Theodore Jackson, Fairfield, CT – (D-2) Limited Journeyperson – Denied

Board voted unanimously to deny Mr. Jackson's application due to lack of documentation of existing license.

David Viera, Stamford, CT - (S-2) Unlimited Journeyperson - Denied

The Board voted unanimously to deny Mr. Viera's application due to lack of sufficient amount of apprenticeship registered time. The Board requests that Mr. Viera appear before them for further discussion.

Booker Washington, III, Waterbury, CT – (D-2) Limited Journeyperson – Conditional approval

Board voted to conditionally approve Mr. Washington's (D-2) application, contingent upon further processing by DCP staff. Board member Tom Casey abstained.
