The Board voted unanimously to impose a civil penalty in the amount of \$3,000 and to impose the revocation of the S-1 license for a period of one year. (Higgins, Champlin)

The Board voted unanimously to order restitution in the amount of \$1,000. (Casey, Champlin)

The hearing concluded at 10:56 AM.

### FORMAL HEARING – Case No. 2017-230 – Alfred Johnson

Acting Chairperson Robert Barrieau convened the formal hearing at 10:56 AM.

The Board reviewed exhibits and heard testimony presented by DCP Attorney Cynthia Fernandez and DCP Inspector Jack Korduner.

The Board voted to impose a civil penalty in the amount of \$6,000 and to order the permanent revocation of the S-1 license. (Casey, Higgins) (Robert Barrieau opposed)
