## **NEW BUSINESS:**

# 1. Application Review Working Group

Chairperson Barrieau stated he, Janita Hamel and Todd Berch continue to review applications for equivalent experience and training. He is also working with Andrea Comer to streamline the application process.

## 2. Application processing - PSI

The Board continued to express their concern regarding PSI's application process as well as difficulty communicating with PSI via phone. Registered/ accepted applicants are not in a "registered" status in the PSI online system preventing them to schedule a test date. A call to PSI is required to resolve this issue. Call wait times are extensive. Chairman Barrieau, as previously stated, continues to work with the DCP Commissioner's office to resolve this issue.

#### 3. Boiler Maker License (BM-1/BM-2) Requirements:

Continued discussion took place regarding the related instruction and on the job training requirements for this license type. Chairperson Robert Barrieau stated a previous decision was made. The decision determined that once you get to the breach, it is no longer in the Boiler Maker License category, it now enters the S-1 License category. The Board so noted.
