#### Discussion of CHFA mobile manufactured home parks purchase program

Discussion on this topic will continue to take place at the Regulations/Legislation Committee meetings. Council members will review CHFA's draft document entitled "Mobile Manufactured Home Parks Pilot Program," make recommendations, and submit these recommendations to CHFA.

Bennett Pudlin introduced a letter from the Housing Program Organizer of CDI (Cooperative Development Institute) to Council Member Al Hricz. CDI is an entity that works along with ROC USA to support resident ownership in mobile manufactured home communities. Al Hricz will distribute this letter to Council members after the meeting.

### EDUCATION COMMITTEE

# DCP TRADE PRACTICES DIVISION COMPLAINT STATUS REPORT:

The Council reviewed a complaint report submitted by DCP Trade Practices dated 8/19/13 to 8/19/14. The Council also noted that Trade Practices has informed the Council that they will be receiving a complaint report every six months. The Council voted unanimously to request that they have an updated copy of complaints in advance of each meeting to be sent out with the agenda (BP, AH).

# **OLD BUSINESS**

1. Continued discussion regarding the review of the Department's Regulations pertaining to Mobile Home Parks.

The Committee continues to meet to work on a draft of the regulations and is making progress. The areas in which the Committee is working on at this time are the following:

- -The notice that goes out to complainants upon filing a complaint
- -Previous DCP formal decisions and court decisions

The Committee is also discussing the possible need for statutory changes, particularly in relation to multi-year leases. The Committee is looking into how other neighboring states approach the issue of multi-year leases and also resident and park owner perspectives on this issue.

The next meeting date of the Regulations/Legislation Committee will be November 13, 2014 at 9:30. At this meeting, discussion will take place on the draft regulations, the topic of long-term leases, and the CHFA proposal for park purchases. A draft should be available for January Council meeting.

Vicky Bullock provided final decisions pertaining to Shoreline Trailer Park Court, LLC and Y & D Mobile Home Park for the Council's review. Vicky reviewed the Shoreline Trailer Park Court decision with the Council.

2. Continued discussion regarding the revisions to the *Rights and Responsibilities of Mobile Manufactured Home Communities in Connecticut Booklet*No discussion took place on this topic.

# **NEW BUSINESS**

1. New Haven Register article: Future of Mobile Home Park in Branford Cloudy as Deadline Nears and related e-mail written by Susan Farricielli

Council Member Myriam Clarkson provided background on the final decision and order issued against Shoreline Trailer Park Court, LLC on October 16, 2013. A discussion ensued regarding

problems relating to health and safety among mobile home park owners and residents, such as those brought on as a result of feral cats and wild animals, and the complex issue of the park owners enforcing the rules to ensure health and safety for all park residents.
