1. CHFA proposed program for resident purchases of mobile manufactured home parks

A copy of the revised version of the document entitled, "Mobile Manufactured Home Pilot Parks Program" was disbursed and reviewed by Council members and CHFA staff.

1. Proposal of new mobile manufactured home park regulations

The document outlining the Council's proposed regulatory changes has been approved as drafted by the Council and is contingent upon further action by the DCP Legislative Liaison. The Council would like a meeting to be scheduled for this purpose.

2. Connecticut law regarding long-term leases

All issues resolving long-term leases in Connecticut have been resolved, with the exception of the issue of rent increases. This topic will be revisited in spring of 2016.

3. Revisions to the Rights and Responsibilities of Mobile Manufactured Home Communities in Connecticut Booklet

Draft revisions to this Handbook have been completed by the Council, and the Council would like to work with the communications staff of DCP to go forward with getting the handbook updated.
