At the February 6, 2020 meeting, discussion took place regarding the widespread issue of employees that are required to be registered as an apprentice upon hire not being registered by the contractor and possible solutions to the issue.

The Board recommends that Executive Orders 7GGG and 7EEE be modified to extend the deadlines for plumbers to complete their continuing education requirements and for course providers to continue offering both in person and interactive online courses. This modification shall take effect immediately and remain in effect for the duration of the public health and civil preparedness emergency, February 9, 2021.
