#### **NEW BUSINESS:**

1. Changes in continuing education requirements for plumbing licensees for the 2020-2021 cycle

New Governors Executive Orders now allow for approve providers to offer on-line classes for plumbing and electrical licensees through December 31, 2020.

On-line classes, in addition to classroom classes, can be for this current year and online for next year's continuing education requirement up to the end of December 2020.

In addition, these Executive Orders include the extension of the deadline for electricians and plumbers to complete continuing education requirements until December 31, 2020. (Note: Contractor P-1 license type holders only are due this year)

Plumbers must still renew their licenses within existing deadline of October 31, 2020, and electricians within the existing deadline of September 30, 2020.
