At the April 19, 2021 Application Review Working Group Meeting, it was determined that the following license types are equivalent:

<u>Out of state license type</u>	<u>Connecticut License Type</u>
Mass Unlimited Journeyman	CT P-2 Unlimited Journeyman

2. Appointment of Lance Hall Unlimited Journeyman

After the meeting held of the Plumbing and Piping Work Examining Board on May 19, 2021 in which Lance Hall had been sworn in as a new Unlimited Journeyman member of this Board, it was determined that he did not qualify as a board member in the position of Unlimited Journeyman, as he would have to be a member of a trade union which he no longer is, and therefore no longer qualifies to hold this appointment.

Connecticut general statutes Sec. 20-331. Examining boards.

(d) The Plumbing and Piping Work Board shall consist of twelve members who shall be residents of this state, one of whom shall be a general contractor or an unlimited contractor licensed for such occupations under this chapter, two of whom shall be unlimited contractors licensed for such occupations under this

chapter, neither of whom at the time of appointment shall be a member or an employee of a member of a trade union or a party or an employee of a party to a contract with a trade union, one of whom shall be a well drilling contractor licensed pursuant to section 25-129, four of whom shall be unlimited journeymen licensed for such occupations under this chapter, who at the time of appointment shall be members of a trade union, and four of whom shall be public members.

3. Substitute House Bill No. 6100 - Public Act 21-37 - An Act Concerning Department of Consumer Protection Licensing and Enforcement, Antitrust Issues, and the Palliative Use of Marijuana and Revisions to the Liquor Control Act

Bill No. 6100 includes changes to Connecticut General Statutes, Chapter 393 requiring written contracts meeting certain specifications for work on private residential property by licensed tradespersons and the requirement for a right to cancel timeframe prior to performing work.
