MINUTES OF PREVIOUS MEETINGS

The Board voted unanimously to approve minutes of the December 17, 2009 Plumbing and Piping Work Examining Board meeting with amendments to page-6 under "Petition For Declaratory Ruling", the Board stating that aeration piping does not include odor control.

APPLICATIONS

Marcello Assis, Stratford, CT – (P-2) Unlimited Journeyperson – Tabled

The Board voted unanimously to table their decision until such time Mr. Assis' credentials are evaluated by the CT Department of Labor and deemed equivalent to the requirements under the CT apprenticeship program.

Donald Emond, Jr., Berkley, MA – (P-1) Unlimited Contractor – No Action Mr. Emond did nor appear today and the Board took no action.

Joseph Jerkowski, Tillson, NY – (P-1) Unlimited Contractor – Denied
The Board voted unanimously to deny Mr. Jerkowski's application due to lack of a required
(P-2) Unlimited Journeyperson license for a minimum of two years.

Tomasz Jezionek, Plainville, CT – (P-1) Unlimited Contractor – Denied

Mr. Jezionek has held a (P-2) Unlimited Journeyperson license since 12/8/09 and is requesting waiver of the two year requirement to sit for his (P-1) Unlimited Contractor examination.

The Board voted unanimously to deny Mr. Jezionek's application due to lack of a required (P-2) Unlimited Journeyperson license for a minimum of two years.

Charles W. Stowe, Ansonia, CT – (P-7) Limited Contractor – Approved (W-8)

The Board voted unanimously to deny Mr. Stowe's (P-7) Limited Contractor application. Mr. Stowe changed his category to (W-8) Limited Journeyperson and the Board voted unanimously to approve Mr. Stowe's (W-8) Limited Journeyperson application, and if successfully passes the (W-8) Limited Journeyperson examination, may apply for the (W-9) Limited Contractor license and appear before the Board for consideration based on a qualifying hardship.

Trevor Vigneault, Farmington, CT – (P-7) Limited Contractor – Denied

The Board voted to deny Mr. Vigneault's application due to lack of required occupational related experience (2,000 hours) and lack of required occupational school related instruction experience (180 hours). Ms. Sheffy recused herself from participating on this matter.

James Walsh, Harwinton, CT – (P-7) Limited Contractor – Denied

The Board voted unanimously to deny Mr. Walsh's application due to lack of required occupational related experience (2,000 hours) and lack of required occupational school related instruction experience (180 hours). The Board suggested DCP Trade Enforcement Division investigate Mr. Walsh's employer(s) concerning violation of CT apprenticeship registration requirements.

Peter West, Webster, MA – (P-6) Limited Journeyperson – No Action Mr. West did not appear today and the Board took no action.

REQUESTING REINSTATEMENT OF LAPSED LICENSE

Alan Glemboski, Collinville, CT – (J-3) Limited Contractor (Lapsed 10/31/08) The Board voted unanimously to deny reinstatement of Mr. Glemboski's license and is requiring him to re-apply and re-test for his license.

Richard Katan, Millerton, NY – (P-2) Unlimited Contractor (Lapsed 10/31/08)
The Board voted unanimously to deny reinstatement of Mr. Katan's license and is requiring him to re-apply and re-test for his license.

David Montanaro, Stamford, CT – (P-2) Unlimited Contractor (Lapsed 10/31/98) Mr. Montanaro did nor appear today and the Board took no action.

CORRESPONDENCE

1. "DRAFT" State of Connecticut Regulations concerning Geothermal Systems.

Jack Guererra, CT Department of Labor Office of Apprenticeship Training Program Manage, appeared before the Board today to discuss the proposed draft regulations concerning geothermal systems. Mr. Guererra deemed geothermal work as an apprenticeable trade and suggested the development of a training program requiring (one year / 2,000 hours) on-the-job training and to mandate the requirement for occupational school related instruction experience as well. Mr. Guererra referenced a November 8, 2005 declaratory ruling from Richard T. Sponzo, Assistant Attorney General, in which it states that if the CT Department of Labor refuses or cannot apprentice a specific training classification, DCP is within their right to establish a training program. Mr. Guererra said that the CT Department of Labor can apprentice the geothermal classification and is extending their cooperation in developing an apprenticeship training outline based on the industry needs, which would then require changes to the geothermal systems draft regulations.

The Board voted unanimously to meet with the Heating Board and the CT Department of Labor Apprenticeship Division for the purpose of establishing a task force for further discussion and input concerning this particular matter.

NEW BUSINESS
