#### **APPLICATIONS**

#### Victor M. Alvarado, Jr., New Britain, CT – (J-4) Limited Journeyperson – Denied

The Board voted unanimously to deny Mr. Alvarado's application due to lack of an apprenticeship completion certificate. The Board is requesting Trade Enforcement open an investigation into Mr. Alvarado engaging in the plumbing trade without a plumbing license or apprenticeship registration and his employer permitting him to perform plumbing work without a license or apprenticeship registration.

#### Kenneth A. Coia, Jr., West Warwick, RI – (P-2) Unlimited Journeyperson – Denied The Board voted unanimously to deny Mr. Coia's application due to lack of a required apprent

The Board voted unanimously to deny Mr. Coia's application due to lack of a required apprenticeship completion certificate from the Rhode Island licensing authority certifying the completion of 8,000-hours of occupational related experience and 720-hours of school related instructions.

# Douglas R. Moore, Noblesville, IN – (P-1) Unlimited Contractor – Denied

The Board voted unanimously to deny Mr. Moore's application due to lack of a required (P-2) Unlimited Journeyperson license for a minimum of two years.

#### Vincent Petralito, Norwalk, CT – (P-2) Unlimited Journeyperson – Denied

The Board voted unanimously to deny Mr. Petralito's application due to lack of required occupational and school related instruction documentation.

# John R. Sablian, Northville, CT – (P-2) Unlimited Journeyperson – Denied

The Board voted unanimously to deny Mr. Sablian's application due to lack of completing the required 720-hours of school related instructions.
