OLD BUSINESS

The Plumbing and Piping Board voted in favor of an alternative gas related continuing education course for License P-2 Journeyperson for the 2013 renewal year offered by the Department of Construction Services by a vote of six to two, with Board Members Frank DaCato and Melissa Sheffy opposed.

Licensed P-2 Journeypersons now have two Board approved course options for 2013 continuing education.

Connecticut Licensed P-2 type Journeyperson's may take the following 7 hour course of study and receive Continuing Education credit that is required of the P-2 Licensed Journeyperson for license renewal year of 2013 in lieu of taking the Plumbing and Piping Boards specific P-2 course for 2013.

DCP COMPLAINT STATUS REPORT

The Board reviewed the report on the 2011 continuing education audit for P-2 licensees.

As a result of the audit, audit letters were sent to 330 of the active 2430 P-2 license holders requesting they show proof of having taken the Board prescribed course prior to license renewal, or if not taken, or taken after renewal, to produce a copy of their completion certificate and assessing a \$100 civil penalty for the violation. The Board reviewed a report of those cases thus far resulting in a civil penalty assessment as well as other Plumbing complaints closed within the last month.

CORRESPONDENCE

The Board received a notice of retirement of Mr. Raymond Jarema of the Department of Public Health, Drinking Water Section, was has retired after 40 years of State service. The Board wishes him their congratulations and best wishes for the future.

The Board discussed changes to the homeowner exemptions pertaining to gas related installation and supply.

The Board further discussed possible proposed legislation limiting the sale of fuel equipment unless such person is licensed or the home owner has a copy of a permit for purchase of such supplies related to oil and gas.

The Board reviewed and discussed Substitute Senate Bill No.1111, Public Act No. 03-172, An Act Concerning the Sale of Electric, Gas and Oil Fired Heating Units.
