OLD BUSINESS

1. Request for exemption pursuant to Sec. 25-133 of Title 25 of the State Well Drilling Board Rules and Regulations

At the April 10, 2014 meeting, the Board voted unanimously that this matter be tabled until the Board receives information from their attorney as to whether or not this Board is allowed to act on this Durham Water Line Project at this time.

At today's meeting the Board, along with Bill Warzecha (DEEP), reviewed the e-mail from Attorney General Raul Rodriguez. After discussion, the following motion was made:

The Plumbing and Piping Work Examining Board grants an exemption pursuant to Connecticut General Statutes Section 25-133 of Title 25 of the Regulations of Connecticut State Agencies (RSCA), to the U.S. Environmental Protection Agency and Department of Energy & Environmental Protection to allow, as part of the well abandonment procedure, the disinfection of more than one hundred drinking water wells solely encompassed by an area identified as Area A of the Durham Meadows Superfund site located in the center of Durham, Connecticut using a fifty (50) part per million (ppm) dose of chlorine rather than 150 ppm as prescribed in Section 25-128-57 of the RCSA.

Furthermore, that an exemption, pursuant to Connecticut General Statutes Section 25-133 of Title 25 of the RCSA be granted to use an alternative method for grouting all abandoned, bedrock-floored wells identified above in a manner as follows; each bedrock well will be filled with fine sand to a depth of about forty feet with remainder of the well bore hole filled with bentonite grout chips to the terminus of the well casing. This will prevent the chance for contaminated well water from spilling onto the surface of the ground in proximity of the well head.

The Board voted unanimously to approve this motion.

2. Raised S.B. Bill No. 412 – An Act Concerning the Enforcement of Certain Occupational Licensing Statutes

Mr. DaCato reported that this bill has passed the Senate, however, there have been some changes. The Board will review and discuss this bill in more detail at a later date.

3. Residential sprinkler system licensing requirements

This item was not discussed.

4. Draft Circular Letter EHS #2014-## Re: DEEP General Permit for the Discharge of Low Flow Water Treatment Wastewater

Ryan Tetreault (DEEP) presented this draft letter for the Board to review. The purpose of this letter is to ensure that local health departments are aware of the existence of this permit, and to ensure that the local building officials who will be receiving receive these permit applications will be communicating with local health departments. Mr. Tetreault stated that Dan Tierney, Office of the State Building Inspector, is in agreement with this letter, however, requested that the first sentence be modified to say, "In conjunction with the Office of the State Building Inspector......." The Board voted unanimously to accept this proposal as presented by Mr. Tetreault today. Board members are invited to join the work group on this topic, which Mr. Tetreault will be coordinating.

5. Substitute Bill No. 5299 An Act Concerning the Findings of the Military Occupational Specialty Task Force

Mr. Bowman reported that this bill has passed the Senate and House, however, there have been some changes. According to this bill, veterans will be required to have their credentials approved by the Department of Labor and will have to sit for the examination before receiving a license.
