# **OLD BUSINESS**

# 1. Achieving proper enforcement for occupational trade licenses

A hearing regarding Senate Bill No. 412 was held on Tuesday, March 11, 2014, at which testimony was heard. Board members are encouraged to submit testimony on behalf of the Board if they were unable to attend the March 11 hearing. Chairperson Chuck Appleby will supply the Board with e-mail addresses of the co-chairs of the General Law Committee so Board members may contact them if interested in giving testimony.

# 2. Residential sprinkler system licensing requirements

The Board briefly discussed current statutes as they relate to the installation of residential sprinkler systems. It was stated that proposed legislation may be necessary in order to initiate changes in current laws.

# 3. Substitute Bill No. 5299 regarding the licensing of veterans

The Board briefly discussed this bill as it relates to current licensing statutes.

# **NEW BUSINESS**

# 1. Request for exemption pursuant to Sec. 25-133 of Title 25 of the State Well Drilling Board Rules and Regulations

Bill Warzecha, Jing Chen, and Drew Kukucka from the Department of Energy and Environmental Protection appeared for discussion regarding the granting of the above-referenced exemption for an upcoming project. After a lengthy discussion, the Board voted unanamiously to table this matter until the April 10, 2014 Plumbing and Piping Work Examining Board meeting, at which time the state and local health departments will be requested to attend and further discussion will take place.

# 2. Building Code Changes

Board member Christopher Bowman expressed his concern that there have been changes in the State Building Code as of February of 2014, and that licensed contractors serving the public may not be aware of these changes. The Board discussed avenues in which licensees could be notified of these changes. The Board requested that a representative from the Office of the State Building Inspector be invited to the April 10, 2014 Plumbing and Piping Work Examining Board meeting for further discussion.

#### 3. Carbon Monoxide Poisoning

Chairperson Appleby informed the Board of a recent carbon monoxide incident in New Hampshire that led to three deaths and one injury and is currently under investigation by the State Fire Marshal in New Hampshire. Chairperson Appleby will pass on more information as it becomes available. The Board briefly discussed accidents of this type and how they relate to current practices within the trade and continuing education in Connecticut.

#### 4. CEU Evaluation Forms

The Board reviewed evaluation forms and requested that two of them be forward to the appropriate school for further review.

- **5.** Proposed Legislation Raised Bill No. 5461 Connecticut Airport Authority The Board briefly discussed this bill as it relates to Connecticut licensing statutes.
