...I am asking for a waiver to allow 5 provisional appraisers. My reasoning is first Scott Ferrari is currently preparing for certification and should be completing it in the very near future. Second Margaret Empasall is currently working for me in a secretarial position but would like to remain active with me for an occasional assignment...

Seven (7) of these provisional will be certified before the end of the year. No additional appraisers will be added to this list.

Additionally we respectfully request that Tim Moore be granted a waiver of Section 20-504-4(j) for Eric Enhoffer, Robert Higgins, Wendy Kangisser, Deborah Quinn, Leo Ruhl, Chuck Saletan, Phil Schlissel, and Sue Shapiro for a total of 8 appraisers until the end of 2005. Six (6) of these appraisers will be certified by year-end. No additional appraisers will be added to this list.

...The reasons for this request are the lack of time to implement the provisions of the law...

Commissioner Gerald Rasmussen made a motion to approve this waiver to December 31, 2005, but Mr. Bowley and Mr. Moore must meet the regulation requirement by January 1, 2006. Commissioner Nicholas Tetreault seconded the motion. The motion carried unanimously.

*3. Eric Morales letter dated February 23, 2005

...I currently have 6 full time provisional appraisers two of which are applying for certifications, Diana Mortensen, RSP.692 and Douglas Miner, RSP.781. I have 4 other provisionals that are in the process of completing the required classes and hours to meet certification requirements. They are Humberto Gil, RSP.697, Scott Malen, RSP.1072, Chris Dale, RSP.711 and William Lengyel, RSP.695. Due to the time frame of May 1, 2005, I am requesting a waiver of this subsection.

Commissioner Nicholas Tetreault made a motion to approve this waiver to December 31, 2005, but Mr. Morales must meet the regulation requirement by January 1, 2006. Commissioner Gerald Rasmussen seconded the motion. The motion carried unanimously.

*4. James Mozzicato letter stamp-dated March 2, 2005

...I respectfully request a waiver extending the time by which I may comply so that I can continue to provide lenders with excellent appraisal reports. Specifically, I am requesting the following:

- 1. A maximum of 8 provisional licensed appraisers on staff at any one time, I currently have 11 provisional appraisers so I will have to give up 3 appraisers;
- 2. A minimum of 1 supervising appraisers would be maintained, and it would be myself. I operate a small business as a sole proprietorship and I am the only supervising appraiser in my company. By May 1, 2006, I project that I will have as many as 4 supervising appraisers (including myself) on staff as 3 of my current provisionals will have attained certification and can be supervising appraisers;
- 3. that the waiver be granted until May 1, 2006 to allow 3 of my current provisionals to attain supervisor status.

Commissioner Sean Hagearty made a motion to approve this waiver to December 31, 2005, but Mr. Mozzicato must meet the regulation requirement by January 1, 2006. Commissioner Gerald Rasmussen seconded the motion. The motion carried unanimously.

*5. Timothy Jackson letter dated February 23, 2005

...I am sure that the change is not to put people out of a job that they have worked so hard to attain, but I feel that, that this is what will happen to me. We worked very hard, as a family, to structure a career change for me. This is a career that I have been looking forward to and one that, I had hoped, would secure a bright future for my family. Because it is difficult to find a supervising appraiser, this change in regulation will cause hardship for myself and my family...

...I hope that after hearing my undeniable concerns, you will advise me as to how I can begin a career that I am extremely anxious to begin...

Commissioner Gerald Rasmussen made a motion to approve this waiver to December 31, 2005, but Mr. Jackson must meet the regulation requirement by January 1, 2006. Commissioner Sean Hagearty seconded the motion. The motion carried unanimously.

*6. Lori Ferrari letter dated February 25, 2005

...At the current time I have 5 active appraisers under my supervision. I would like to propose that these 7 appraisers (5 active and 2 inactive) that I supervise be grandfathered. I would like to be approved to maintain the 7 active appraisers. Once any one of these 5 active appraisers becomes certified, then, at that point, I will reinstate Tim Jackson and eventually Michael Pellegrini into their position as an active provisional appraiser. I will not exceed the 5 provisionals in active status at any time. Once I have met my obligation to these appraisers, I am more than willing to abide to the new regulation permitting only 3 provisional licensed appraisers at any one time...

Commissioner Gerald Rasmussen made a motion to approve this waiver to December 31, 2005, but Ms Ferrari must meet the regulation requirement by January 1, 2006. Commissioner Sean Hagearty seconded the motion. The motion carried unanimously.
