MINUTES OF PREVIOUS MEETINGS

It was moved by Commissioner Tetreault, Commissioner Rasmussen 2nd, and the motion carried unanimously to approve the minutes of the July 11, 2012 CT Real Estate Appraisal Commission meeting.

OLD BUSINESS

1. Continuing Education Audit

Examiner Linda Kieft-Robitaille provided an update on the status of the CE audit of 361 licensed appraisers and reported that 314 licensees were found in compliance, 6 voluntarily surrendered their licenses and 28 signed agreements and paid the penalty fee. The Department continues to work on the remainder of the audit.

2. CT Real Estate Academy

Examiner Kieft-Robitaille advised the Commission that the CT Real Estate Academy is currently under review by the Department due to their incomplete 'class sign-in sheets' and 'course certificates'.

- <u>R. Bruce Hunter, RCG.297 Seeking post approval for teaching</u> It was moved by Commissioner Rasmussen, Commissioner Hagearty 2nd, and the motion carried unanimously to grant Mr. Hunter fourteen (14) hours credit for the 2010-2012 CE cycle.
- McKissock Course hours Examiner Kieft-Robitaille brought to the attention of the Commission a concern regarding McKissock 'distance education' in that the online courses can be completed in much less time than the allotted completion time.
