### MINUTES OF PREVIOUS MEETINGS

#### **NEW APPLICANTS**

Examiner Linda Kieft-Robitaille informed the Commission that there has been no communication from Mr. Cammarata relative to this matter. The Commission took no action.

2. Autumn Brooke, RSP – Review of samples

Ms. Brooke appeared before the Commission with her sponsor, Garry Brooke. It was moved by Commissioner Baron, Commissioner Rasmussen 2<sup>nd</sup>, and the motion carried unanimously to approve the additional work samples.

3. Timothy Lillis, RSP – Approval of logs and sample selection

#### **NEW BUSINESS**

The Commission requested that Mr. Goncalves provide the Department with samples of his work forms for review and discussion at the February meeting.

#### **OLD BUSINESS**

1. Provisional appraisers not upgrading – Can they reapply/extension Examiner Linda Kieft-Robitaille reported that 11 Provisional appraiser licenses were set to expire on December 31, 2014 and each were contacted by email. Nine responded and were granted extensions until April 2015. Ms. Kieft-Robitaille reported that the ASC imposes no time limit for holding a Provisional license, that it is up to the individual state appraiser regulatory agency to impose its own regulation on this matter.

The Commission directed DCP staff to research the practices of other New England states for discussion at the next meeting.

#### 2. DOT / E.O.C. Appraisal Analysis

Mr. Terrence Obey, Director (ROW) appeared before the Commission on this matter.

Commissioner Galvin prepared a letter summarizing his review of DOT's internal structure between the Appraisal and Property Management Division and the Acquisition and Relocation Division, as well as the duties of those specifically involved in the Acquisition and Relocation Division.

After further discussion, the Commission recommended that Mr. Obey submit a revised Estimate of Compensation form (EOC) based on the changes discussed at today's meeting and that Commissioner Galvin will amend his letter to reflect today's discussion which will be forwarded to the Assistant Attorney General for review and then final review by the Commission before being presented at the next meeting for a decision.
