Mr. Maloney stated that he will report back on this matter at the next meeting and will ask the Commission for their recommendations.
- Commissioner Baron asked Attorney Bullock for the status of 'Provisional Supervisor Responsibilities' and stated that it should be included in the next mandatory law class. Attorney Bullock reported that she and Commissioner Rasmussen are researching this matter.

LEGAL:

Formal Hearing: Case: 2015-164 - Docket No. 2016-345

It was moved by Commissioner Baron, Commissioner Sepso 2nd, and the motion carried unanimously that respondent is placed on probation effective immediately until September 14, 2017; that respondent is to submit a quarterly log for the calendar year from which the Department may select 3 samples, the due dates are December 15, 2016, March 15, 2017, June 15, 2017 and September 1, 2017; that prior to the July 2017 Appraisal Commission meeting, Respondent is to provide two appraisals to the Department for review by the Commission members at its monthly Commission meeting; that respondent is to complete an 'in person' 15-Hour USPAP course, Basic Appraisal Principles and Basic Appraisal Procedures courses including passing the exams; that Respondent has until September 14, 2017 to complete the coursework; that coursework completed cannot count toward any upcoming CE cycle; that Respondent is to pay a civil penalty in the amount of \$750.00 which is to be remitted on or before November 30, 2016, and that respondent is not to supervise for three years after completion of her probation.
