- Jim Kyle commented on the Appraiser Qualifications Board (AQB) release of its Third Exposure Draft of Proposed Changes to the Real Property Appraiser Qualification Criteria and expressed his concern specifically regarding the proposed reduction of required experience hours for each credential, and the substitution of (PAREA) modules for the experience requirement.
