AQB Criteria Change - Implementation Date/ Previous Applicants Reapplying Attorney Bullock reported that the AQB Criteria changes have been submitted to the DCP Legislative Liaison and will be effective upon passage of the Regulations. Attorney Bullock added that at submission, she prefaced it as a Federal ASC requirement and is a priority.
