Peter Tracey, Chair of CSCPA Ethics Committee, provided the Board with a written summary of the September 04, 2008 ethics committee meeting. He thanked the Board for their interest in his feedback. SBOA is currently reviewing regulations pertaining to firm names, contingent fees, results of investigations, client records, outsourcing, AICPA's & CSCPA's intent to adopt IESB Code of Ethics & differences between IEFB & AICPA (CSCPA) codes. Mr. Tracey will provide the Board with information regarding these matters.

The Board noted the list of individual applications for CPA Certificate, Registrations and CPA Licenses approved by staff between September 08, 2008 thru October 06, 2008. The Board also noted the list of Firm Permit to Practice applications approved by staff between September 08, 2008 thru October 06, 2008.

Fred J. Bauters, Chief Risk Officer, from Crowe Horwath LLP was present to answer any questions the Board may have had in respect to their application for a Firm Permit to Practice Public Accountancy. Michael Weinshel made the motion to approve the Firm Permit application for Crowe Horwath LLP. Motion was seconded by Richard Gesseck; motion passed with no abstentions, and Philip DeCaprio voted against the motion.

The Board reviewed the request from CPA Exam Candidate Bonnie J. Soucy for the extension of the notice to schedule for the Financial Management and Reporting component of the CPA Exam due to health reasons. Michael Weinshel made the motion to approve Ms. Soucy's request. Motion seconded by Philip DeCaprio; no votes against and no abstentions.

The Board reviewed a request from Andrea B. Morey to extend her testing window due to unexpected surgery and rehabilitation which disabled her from taking review courses to prepare

for the CPA Examination. Michael Weinshel made the motion to approve Ms. Morey's request. Philip DeCaprio seconded the motion; no votes against and no abstentions.

Motion made by James Ciarcia to table Victor Grabicki's request for an extension of his conditional passing credits for three parts of CPA Examination due to a medical problem and hospitalizing, while awaiting a letter from the doctor. Thomas Reynolds seconded the motion; no votes against and no abstentions.

The Board discussed the availability of PCAOB reports. The Board's Executive Director Guay has begun posting the reports for review on a secure portion of the web site. He also informed the Board the 2007 Inspection of KPMG LLP has been received by this office.

Under Regulatory Activity, Attorney Adams informed the Board she is working on revising the Quality Review Regulations, she also provided them with a draft of the Experience Regulations of which they had a lengthy discussion on how some of the language should read and asked Attorney Adams for an updated draft.

Under New Business, discussion centered around whether, or not we should allow firms to apply for an extension in completing their Peer Reviews for Firm's who are in compliance and who have consistently received unmodified opinions. No decision was reached but the Board agreed to continue this discussion at a later date.

The Board discussed the upcoming NASBA 101st Annual Meeting on October 26-29, 2008 in Boston, MA & the NASBA Forum of International Accountancy Regulators on October 28-30, 2008 also in Boston, MA & who may be attending.

Under Public Comment Arthur Renner, Executive Director of the Connecticut Society of Certified Public Accountants made brief comments.
