 - 5 letters of recommendation from personal and professional references affirming Respondents rehabilitation
 - \$5000 in civil penalties
 - At the time of reinstatement 40 hours of CPEs in each of the 2 calendar years preceding reinstatement

- Passage of the AICPA ethics exams with a grade of at least 96%
- At the time of reinstatement 120 hours of accounting CPEs in each of the 2 calendar years preceding reinstatement
