Attorney Isales spoke to the Board about the mission of The Office of State Ethics. Attorney Isales stated that the mission of the agency is to practice and promote the highest ethical standards and accountability in state government by providing education and legal advice, ensuring disclosure, and impartially enforcing the Codes of Ethics. Attorney Isales also stated

that all state officials and lobbyist, with the exception of judges, are covered under the ethics code. She encouraged the Board to contact The Office of State Ethics with any questions.
