OLD BUSINESS

CPE Reciprocity – Legislative Update

Bonnie Stewart, Executive Director, CT Society of CPAs, reported that Senate Bill 327, 'An Act Concerning License Renewal Requirements for Certified Public Accountants', was approved by General Law Committee and by the Senate and is awaiting action by the House.

NEW BUSINESS

Policy regarding exam extension requests from candidates who took exam sections as candidates in another state, but are now applying in Connecticut Mr. Virnelli asked the Board to set a general policy on this matter.

Mr. Schuyler made a motion that the Board's general policy is that a candidate must qualify first in Connecticut; generally the Board will not consider an extension, but case by case basis would be considered. The motion was seconded by Ms. Fox. All remaining board members voted in favor.

AICPA Board of Examiners Update

Mr. Virnelli reported on the March 28, 2018, AICPA Board of Examiners conference call, which included the highlights of their January 25-26th 2018 meeting in Las Vegas, Nevada. Some of the topics discussed: most states granted the three month, one window, extensions to candidates impacted by the 2017 second quarter score hold; no issues with exam, trying to implement continuous testing with no blackout dates and no windows; assessing the 2017 tax reform legislation beginning in January 2019; the launch of new part of exam showed less volume of test takers but did rebound; alternate pathways to become a CPA.

NASBA Eastern Regional

Mr. Virnelli reported that at this time no board members have volunteered to attend the June 5-7, 2018 NASBA Eastern Regional Meeting in Orlando, Florida.

CPE/EXAM EXTENSION REQUESTS

Kelly A. Harper – Exam Section

Mr. Schuyler made a motion to approve an extension to September 30, 2018. The motion was seconded by Ms. Triplett. All remaining board members voted in favor.

Jason Tellone - Exam Section

Ms. Fox made a motion to approve the requested two month extension. The motion was seconded by Mr. Lyne. All remaining board members voted in favor.

- Mr. Virnelli thanked DCP Legal Division intern, Jeremy Rocha for all his assistance with the CPE audit and for a job well done.
- Mr. Virnelli introduced new DCP attorney Cat Arsenault to the Board.
- Bonnie Stewart remarked on the importance of Board presence at the Capitol
 and the fact that they don't have a complete understanding of the CPA world.
 Ms. Stewart added that there is no DCP lobbyist who represents the boards at
 the Capitol and suggested the Board draft a paper or meet with a committee at
 the legislature to give them a better understanding of the profession. She asked
 the Board to think about it in advance of the next legislative session and she is
 happy to help in any way.
