Janita Hamel's response-

"It exists on all my Board reports to provide the closure notes for the complaint file for the Boards to review.

Those are the closure notes from the investigator regarding their investigation of the complaint submitted and the results of the investigation.

In the cases from 2 months ago, (06/01/20 to 07/31/20 – PELS Board Report)

The fictitious/anonymous complainant made allegations which the respondent disputed and claimed were false.

Respondent also stated that his application was sent to the PELS board for review and approval. (That does not mean it was approved – only that they submitted their application for review)"

The investigator closed the complaint file as unsubstantiated and insufficient evidence. Anonymous/Fictitious people do not exist, and can not be contacted for verification. The complaint file is closed for those reasons.

The investigator also wanted the board to know that this person's application was coming to them for review because there is no further action to be taken by Investigations without documented proof of the allegations. (which does not exist because of anon/fict. People)
