This is in regards to a complaint alleging that a land surveyor was negligent in a survey map involving an existing garage that was being replaced with a new garage. One corner of the new structure was built across the property line. The department was assisted by land surveyor Michael Wilmes in the investigation.

The Board was presented with Mr. Wilmes' letter of recommendation, which stated that although the licensee was not responsible for the garage being built across the property line, he did find some deficiencies in the survey map. In lieu of a hearing, the licensee agreed to the issuance of a Letter of Reprimand.

Motion made by (10) seconded by (11) to accept the agreement and issue a letter of reprimand. Motion carried.

F-2 Docket 07-798-Settlement agreement

This is in regards to a complaint alleging that a land surveyor engaged in a conflict of interest by revising an existing survey for a client without notifying the client. The revised survey changed a boundary line between two properties. The land surveyor made this change after receiving information from an attorney for the owner of the adjoining property that led the land surveyor to the conclusion that his first survey was incorrect. The revised survey also failed to comply with all regulations concerning bearings and distances along all boundary lines, and failed to list the area of the property in acres or square feet. Land surveyor, Larry Fisher for this investigation, assisted the department.

Mr. Fisher's conclusion was that the land surveyor should have notified his client before revising the survey and that the revised survey did not comply with all the requirements of Regulations of Connecticut State Agencies, Section 20-330b-2(d). In lieu of a hearing, the licensee agreed to the issuance of a Letter of Reprimand.

Motion made by (12) seconded by (10) to accept the agreement, which requires the licensee to attend an ethics program and a Letter of Reprimand. Motion carried.

Mr. Giel asked if the evaluation of foreign degrees for engineering applications helps in the review process. Chairman D'Andrea stated that the evaluations of foreign degrees, puts these applicants on somewhat of a same plane. Mr. Giel stated that he felt that the board would be serving the land surveyor applicants if they have their foreign degrees evaluated. Mr. Giel stated that if applicants want to claim educational credit for a foreign degree than they must provide an evaluation with an emphasis on surveying.

Policy

Motion made by (10) and seconded by (11) to advise land surveyor candidates, that if they wish to have their foreign degrees considered for credit, they must provide a formal evaluation with their application with an emphasis on surveying. Motion carried.
