Huntsman stated that Chapter 594a does not authorize PCs for the joint practice of architecture and land surveying, or engineering and land surveying. Therefore, land surveying can not be listed as a PC for the joint practice for architecture and/or engineering.

F-Complaints

F-1 Complaint #2006-7564 The complaint alleges that an environmental company performed engineering work on storm water drainage systems. (Dist. 2)

Mark Austin assisted the Department with this investigation and felt that the activities of the company did not constitute engineering. The Board determined that there was not a violation of the regulations, because the respondent was dealing with the environmental elements rather than the engineering.

Motion made by (3) seconded by (5) to dismiss the complaint. Motion carried.

F-2 Complaint against a land surveyor alleging that the land surveyor failed to include a right-of way for a driveway on subdivision plans submitted to a zoning board. Mr. Richard Martel, a volunteer from the CALS list stepped down to review the complaint. (Dist. 3)

Motion made by (11) seconded by (12) to dismiss the complaint with a Letter of Caution. Motion carried.

G-Other Items-

Immigration laws in regards to Connecticut PE & LS applications-

The Board has received numerous applications from the state of New York that have allowed applicants to sit for the national exams in New York, but will not grant a license in their state until they have met the requirement of being a US citizen or as an alien lawfully admitted for permanent residence in the United States (green card). The Board has questioned whether Connecticut is in violation of any laws when approving these applications for licensure.

Assistant Attorney General Peter Huntsman stated that the Board may grant a license to a resident alien. The issue is if they are illegally in the country, as long as they are in the country legally and hold a green card, the Board cannot deny these individuals to practice their profession.

The Board presented many scenarios to Attorney Huntsman for consideration. Attorney Huntsman stated that if the statutes in Connecticut do not require the Board to look for alien status or restrict the issuance of a license based on alien status, then the Board

would be required to grant that license. The Board cannot deny a legal alien licensure on the basis that they are not a US citizen.

Chairman D'Andrea stated that when he spoke with the administrator from the New York Board regarding these applications, the administrator stated that the individuals were not granted licenses because they do not have legal status. Therefore, since we have several applications from New York who have passed both NCEES exams in New York and have not been granted a New York license, is the Board permitted to inquire as to proof of alien status.

Atty. Huntsman advised the Board that there is no restriction to ask the question of the applicant why a license was not granted.

Motion made by (9) seconded by (6) to inquire from the applicant and the clerk of the New York Board as to why a New York license was not issued. Motion carried.

Policy- Board requires documentation in writing from the individual and State Board as to why a license was not issued after meeting the criteria for sitting and passing the NCEES exams.

Motion made by (1) and seconded by (5) to adjourn the meeting. Motion carried.

Meeting adjourned at 12:00 pm.

The next meeting for the Board is scheduled for January 22, 2008.
