Legal Division- Updates by Attorney Schwane

D-New Business

D-1 Discussion regarding regulations requiring surveyors to sign and seal documents released to the public. (Dist. 4)

Mr. Giel initiated a discussion regarding the distribution of unsigned documents to the public. The Connecticut Association of Land Surveyors (CALS) has inquired of the Board's position if surveyors can release digital CADD files to the public without signature and seal. It seems that some towns and municipalities are requiring CADD files of their surveys as part of their approval process. This puts the surveyors in a tough position, where they do not want to go against the towns or municipalities since they want to get their projects approved, nor do they not want to go against the Board's Rules & Regulations of not being able to sign and seal the CADD file. Mr. Giel is inquiring whether or not it is permissible for the Board to distribute a letter to the towns and municipalities confirming that surveyors are not permitted to release unsealed materials in violation of State statutes and regulations.

Mr. Giel will formulate a letter for review by the Board.
