Motion made by (3) seconded by (5) to accept the minutes of August 18, 2009 as written. Motion carried with one abstention (7).

Legal Division- Updates by Attorney Schwane

A-Cases:

Case #2006-7564- Alleged practice of engineering by an unlicensed individual: This case was previously reviewed by the Board and dismissed. The complainants brought up new issues and Mr. D'Andrea stepped down to review this case. Mr. D'Andrea reviewed the complaint and spoke with all interested parties. Mr. D'Andrea's recommendation is to dismiss this complaint

Motion made by (2) seconded by (7) to dismiss. Motion carried with one abstention. (5)

B-The meeting with Commissioner Jerry Farrell and the chairs of the Engineering, Architect and Landscape Architect Boards regarding the changing of statutes and regulations for electronic signatures and seals was held on September 9, 2009.

Other issues discussed, were the letters that the Board wants to send to the towns regarding the release of digital files. Atty. Schwane is to meet with the commissioner regarding these letters Atty. Schwane also forwarded the revisions to the draft by the Board to the DOT and is waiting for a response.

Chairman D'Andrea stated that there are three separate issues that the Board wanted to emphasize to the commissioner;

- 1) The towns cannot demand the professionals submit their vector CADD drawings, but licensees may offer them in PDF files or raster image. The demand by towns is inconsistent with the current regulations.
- 2) Ways to clarify the distinction between land surveying and geographic information mapping.
- 3) Find a way to get the transfer of information with digital signatures into our regulations. The chairs were advised that the Boards could proceed with the regulation change to incorporate this change without a statute change.

C- State Library-Proposed regulations for filing maps will be revisited on 10/14/09.

D-New Business

D-1 Draft from the Department of Environmental Protection (DEP) regarding instructions for applications to the DEP-Sec. 22a-361-3 Surveys and Drawings for feedback from the PELS Board. (Dist. 4)

The Deputy Commissioner of Consumer Protection, Jackie Mandyck, Vince McDermott, Chairman of the Landscape Architect Board, Robert Kuzmich, Board administrator to the Architect and Landscape Architect Board and Barbara S Maziarz, administrator to the PELS Board met with representatives from DEP to discuss the information that is on the OLISP Application requirements. Mr. McDermott went over each of the paragraphs and explained where the information is correct and where only licensed professionals such as land surveyors, professional engineers and landscape architects should be listed as the only acceptable professionals to sign or submit proposals. Deputy Commissioner Mandyck stated that Consumer Protection is more than willing to work with DEP so that their requirements on applications do not conflict with the regulations for DCP licensees.

The DEP also asked that they would like some feed back regarding the draft (residential docks) Sec. 22a-361-3 from the PELS Board.

The Board will review the document regarding residential docks and provide their comments to be forwarded to DEP.
