G-Other Items

G-1 Commissioner William M Rubenstein-The Board invited Commissioner Rubenstein to their meeting to discuss the difficulty they have encountered in the past years in regards to updating statute changes.

Commissioner Rubenstein advised the Board that the Department is going forward in regards to the "Use of Electronic Signatures by Professional Engineers and Land Surveyors".

The Board is seeking changes in the statutes in regards to education by requiring an accredited degree in engineering. Commissioner Rubenstein stated that he would like to be educated in regards to the requirements in other states, how many applicants would be excluded with this statute change, and was there any litigation from past negative decisions made by the Board.

Chairman D'Andrea stated that the Board is trying to have a baseline in regards to education but has established policies to be consistent on the national level and understands that the Board does not implement changes that would be egregious to the majority. Chairman D'Andrea stated that the Board will continue with the policies that have been established and still continue to try to make the statute changes.

The Board will begin to gather the information and provide this data to the commissioner.

G-2 Robert Zygmunt, PE-10:00 a.m. appointment with the Board.

Re: Discussion of having CT adopt a separate specialty license for structural engineers.

Robert Zygmunt and Douglas Graham who are members of the Structural Engineers Coalition Board, appeared before the Board to discuss the separate discipline specific licensing of structural engineers. This committee was started about a year ago to explore structural engineer licensure in the state. Primary goal is public safety; there are about 11 states that have specific licensure in structural engineering.

Mr. Zygmunt is looking for guidance by the Board in regards to the type of Acts (full, partial or transitional) that would meet least resistance from organizations and if they would have the support of the Board.

Chairman D'Andrea stated that anything that would restrict any activity by any group of individuals or professionals would be difficult to gain approval. Therefore, a full practice act would not likely pass.

Chairman D'Andrea stated that the Board would not have any opposition, but advised that this would require a statutory change and that would require a lot of work and working with legislative groups.

Motion made by (7) and seconded by (8) to adjourn the meeting. Motion carried.

Meeting adjourned at 10:55 am.

The next meeting is scheduled for November 29, 2011.
