A-1 Letter from Jayesh Mehta dated July 17, 2014. Re: Requesting waiver of the FE exam. Applicant was approved to sit for both part of the exam in February 1998. (Dist. 2)

The Board held a discussion regarding the Board's policy of not waiving the Fundamentals of Engineering Exam. The Board has been consistent of not waiving the FE exam since 2007.

Motion made by (5) seconded (9) to deny the waiver of the Fundamentals of Engineering Exam. Motion carried.

AA-1 Letter from John Roberge dated 7/30/14. Re: Companies that appear to be offering professional engineering services without proper credentials. (Dist. 2)

Mr. Roberge appeared before the Board to get some guidance in regards to licensure of engineers and engineering firms offering engineering services. Mr. Roberge has found that some municipalities have awarded contracts to firms who are not properly registered.

The Board noted that if the licensed engineer is representing an engineering firm and offering services, then that firm must be registered with the Board.

The Board advised Mr. Roberge that in order for the Board to take any action he must file a complaint and the process is as follows: Complaint would be investigated by our enforcement division to gather information and determine if there have been alleged violations: if alleged violations are found, the complaint is forwarded to our legal division and in most cases an administrative hearing is held. If there is a settlement agreement, the agreement is presented to the Board for their approval. The Board is the eventual decision maker.
