The regulation has would be put into a more understandable form to avoid misinterpretation or misunderstanding and have it conform with the actual practices of today. The Board also asked for a summary to Public Act 13-216 which allows a professional engineer who is not residing or engaging in professional engineering in Connecticut to surrender their license in Connecticut and then when they return only pay the current fee.

Reconsideration

Miledner, Kenneth W – Appeal of Board's decision to deny application based on a lack of a basic degree in engineering. (Dist. 2)

The board deliberated for an extended amount of time regarding the application and other applications who do not qualify as Model Engineers as defined in the NCEES Model law. It has been the policy of the Connecticut Board not to grant licenses to individuals who do not have ABET accredited undergraduate engineering degrees.

Motion made by (1) seconded by (3) to reaffirm the Board's prior decision not to grant request for reciprocity. Motion carried.

Ventre, Nicholas J –Appeal of Board's decision to deny application based on a lack of a basic degree in engineering. (Dist. 2)

The Board reviewed the application noted that there were no basic design core engineering courses and affirmed their original decision of denying the application for reciprocity due to the lack of a qualifying engineering degree.

Motion made by (1) seconded by (5) to affirm the Board's original decision and deny application for reciprocity. Motion carried.

Vranis, Apostolos -Application was denied by the board under Class 4 based examinations that were taken were not NCEES. Received documentation that NCEES PE exam was taken in Maryland.

The Board confirmed that the NCEES principles and practice of engineering exam was passed. However, the Fundamentals of Engineering Exam was not passed. The policy of the Board is that the applicant must have a basic degree in engineering, the required engineering experience suitable to the board and the passing of the NCEES FE & PE exams in order to meet the standards for licensure in CT.

Motion made by (1) seconded by (2) to reaffirm original decision of denying application based on not taking and passing the NCEES Fundamentals of Engineering Exam. Motion carried.

G-Other Items: Meeting held at the CSPE office.

Mr. Redniss provided a report from the meeting that was held on January 5, 2014 at the CSPE office.

Mr. Redniss stated that the discussion involved the proposed statute changes that were processed last year. A meeting is scheduled for January 30, 2014 to go over the proposed changes and to eliminate the PDHs hours. These proposed statute changes will be provided to the board at one of their scheduled meetings when available.

Mr. D'Andrea reiterated that the main change to the statutes is a 4-year degree in engineering and no waivers of the exams.

Mr. Redniss brought up the subject of the use of rubber or embossed seal in the regulation as opposed to the standards where it says that it shall be an embossed seal. Attorney Schwane will look into Section 20-300-10 (b) regarding license seals and stamps.

Motion made by (8) seconded by (7) to adjourn. Motion carried. Meeting adjourned at 11:15 am
