A-1 State Specific Exam Information- Since the PS exams are moving to a computer-based format, NCEES will no longer register or administer the state-specific exams. C-New Business

C-1 Proposed regulation amendments for the Professional Engineer and Land Surveyor Board that the Board voted to have DCP start the regulation process. This draft deals with several issues, one being the change required by Public Act No. 13-216 concerning the surrender of engineering license. Attorney Steven Schwane forwarded this draft to Gary Berner on 9/9/13.

Leslie O'Brien, Legislative Director, who replaced Gary Berner has been provided with this draft. Ms. O'Brien should be available to discuss these proposed regulations amendments with the Board at their meeting.

Ms. O'Brien introduced herself to the Board and advised them that she is working with the department's legal director, Julianne Avallone to develop a system to deal with new regulations or proposals for amendments to existing regulations, where the department can track the progression of the proposed legislative changes from beginning to end.

Ms. O'Brien stated that the department is reviewing the Board's proposed draft and will send back the Board's language and any additional language that the department has amended.

Chairman D'Andrea stated that in addition to the draft of Public Act No. 13-316, the Board is trying to change some sections of the statutes in regards to the requirement of education and no waivers of the exams.

Ms. O'Brien stated she will check on the past history of the proposed legislative changes and is looking forward in working with the Board.
