Mr. D'Andrea stated Mr. Galton can forward the information to the Board administrator for the Board's review. Mr. D'Andrea stated that since there were two engineering board members that were not able to the attend the meeting, that the discussion and additional information will be discussed at the next meeting for everyone's input.

G-2: Matt D Carroll- Mr. Carroll has a 10:00 am appointment with the Board to discuss the Board's policy regarding a 4 year degree in engineering. (Dist. 2)

Mr. Carroll understood the Board's policy in regards to a 4-year engineering degree.

The Board reiterated that the Board does not pre-approve applicants to sit for the Fundamentals of Engineering exam, however when applying to become registered as an Engineering-In-Training the education requirement must be completed.

The Board encouraged Mr. Carroll to sit for the Fundamentals of Engineering exam even though he will not meet all the registration requirements as an Engineer-In-Training.
