C-1 Rodney Galton applied under Class 4 and was denied by the Board based on the lack of a 4-year engineering degree. Mr. Galton appeared before the Board on 4/24/18 to discuss his experience and education. Mr. Galton provided additional education information for a formal discussion with Board.

The Board reviewed the additional information regarding education and agreed to advise Mr. Galton as follows: The Board has determined that the combination of your degree, work experience and additional coursework are not equivalent to a four-year ABET accredited engineering degree, which has been the policy of the Board to require for licensure in the state.

DD-1 Public Act No. 18-141: Changes to Section 20-306a and Section 20-206b (Dist.4)

Public Act changes the ownership of a PC or LLC to require 2/3 of ownership by Connecticut licensed professional engineers, land surveyors, architects or landscape architects.

DD-2 Clarification of policy concerning applicants who passed the fundamentals of engineering exam and hold non-engineering undergraduate degrees but hold a masters degree in engineering. Are EIT registrations issued?

Applicants with foreign undergraduate degrees and a US master's degree are issued EIT certificates without the evaluation of their undergraduate degrees.

The Board's discussion reiterated that in order to take the national Fundamentals of Engineering Exam, those candidates do not have to be pre-approved by the Board to sit for the exam. However, in order to become registered as an Engineer-In-Training, a 4-year degree in engineering must be met.

Those individuals who hold a non-engineering undergraduate degree with a masters degree in engineering will be issued a registration recognizing that they passed the Fundamentals of Engineering Exam, but advising them that it will not guarantee them the approval to take the Principles and Practice exam in Connecticut. In some cases, the Board may recognize additional courses taken by an applicant in combination with experience in engineering as equivalent to an ABET accredited undergraduate degree.

Two applications for the Board's review:

- a) **Gleason, Christine**-passed FE exam on 12/30/17-holds an undergraduate degree in chemistry and master's degree in environmental engineering.
- b) **Sirotko, Stephen J**- passed FE exam on 8/3/17-holds an undergraduate degree in psychology and math and master's degree in civil engineering.

The two applications are approved EIT registrations with the advice of the Board's policy in regards to the approval of the principles and practice exam.
