REQUESTING REINSTATEMENT OF EXPIRED LICENSE

John W. Middleton, Houston, TX, (F-1) Unlimited Contractor (Expired 10/31/07)

The Board voted unanimously to deny Mr. Middleton's request due to his license expiring beyond the 365 day statutory limitation to reinstate. Therefore, Mr. Middleton would have to re-apply and re-test for his (F-1) Unlimited Contractor license.

PETITION FOR DECLARATORY RULING

In the Matter of: Yuriy Rudshteyn

Mr. Rudshteyn and his legal counsel, Paul Tagatac appeared before the Board at their 10/28/08 meeting with regard to Mr. Rudshteyn's (F-1) Unlimited Contractor and (F-2) Unlimited Journeyperson Fire Protection Sprinkler Work license applications which the Board has previously denied.

Attorney Tagatac is requesting a declaratory ruling as to Mr. Rudshteyn's qualification for an (F-1) Unlimited Contractor license, and in the alternative, a declaratory ruling about Mr. Rudshteyn's qualification to receive an (F-2) Unlimited Journeyperson license, and in the event the Fire Protection Board determines that Mr. Rudshteyn does not possess the required occupational and school related instruction experience, Attorney Tagatac requests a declaratory ruling about the specific area or areas where such Board deems Mr. Rudshteyn's experience / instruction deficient.

This matter was tabled at the Board's 10/28/08 meeting for further review and discussion at their December 23, 2008, pending Board inquiring with Jack Guerrera, CT Department of Labor Manager and Raul Rodriguez, CT Assistant Attorney General / Fire Protection Board Legal Counsel.

Due to lack of a representative from the CT Attorney General's office at the Board's December 23, 2008 meeting, the Board voted unanimously to table this matter to their next meeting scheduled for Tuesday February 24, 2009.

The Board voted unanimously at their February 24, 2009 meeting to re-schedule this matter to their next meeting scheduled for Tuesday, April 28, 2009 at 11:30 a.m., at which time Yuriy Rudshteyn is to be present to answer questions by the Board concerning his on-the-job training and related instruction experience. The Board also agreed to keep the petition for the declaratory ruling open beyond the statutory 180 day period.

NEW BUSINESS

- 1. Mr. Waskowicz informed the Board on an e-mail he received from Mr. Hurlburt concerning new directives to PSI Examination Services, that all "F" type license applications shall not be approved by PSI Examination Services regardless of whether such applicant has the required apprenticeship completion letter or in the case of a contractor applicant meeting the two year journeyperson requirement. The application shall not be approved without further approval by the Fire Protection Licensure Board. All "F" type applications shall have fees processed, upload all information and blocked from taking an examination. The application is then mailed back to DCP for further review by the Fire Protection Licensure Board.
- 2. Mr. Waskowicz was inquiring on behalf of Mr. Wypychoski, the status of the Board's request at their 10/28/08 meeting, concerning the insertion of the word "fire protection" in front of any reference to the word "engineer" throughout Chapter 391.
- 3. Mr. Miller informed the Board on some discussion floating around about pre-engineered alternate fire sprinkler systems. Mr. Waskowicz likened the system to a spider web. Mr. Hollis stressed the fact that a properly licensed fire protection sprinkler work license holder is the expert to be dealt with concerning any installation of fire protection systems.
- 4. Mr. Miller informed the Board that the rata for both the building code and fire code was up for legislative review and that there was some technical language and both were pulled back until it can be straighten out.
- 5. Mr. Waskowicz informed the Board on a bill in the Governor's budget under "no new taxes", proposing to increase the license and apprenticeship registration fees. Mr. Waskowicz said he testified at a public hearing that he has no problem with an increase in license fees as long as there in an increase in the number of investigators, which will produce more revenue, and that the monies should go to the department.

There being no further business, the meeting adjourned at 12:23 p.m.
