Docket Number 16-115 CVS Pharmacy #350

Attorney Antonio Santoro presented this case. Commissioner DeFazio 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for failing to remove outdated non-legend drugs from the store shelves. This agreement calls for a \$2,000 civil penalty.

Commission Action: Commissioner Beaudin moved, seconded by Commissioner Goodmaster and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-140 CVS Pharmacy #953

Attorney Antonio Santoro presented this case. Commissioner DeFazio 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for failing to remove outdated non-legend drugs from the store shelves. This agreement calls for a \$1,000 civil penalty.

Commission Action: Commissioner Carbray moved, seconded by Commissioner Beaudin and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-195 CVS Pharmacy #1180

Attorney Antonio Santoro presented this case. Commissioner DeFazio 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for (a) failing to maintain the pharmacy premises, in a clean, orderly and sanitary condition; (b) failed to implement a QA program to detect, identify and prevent prescription errors. This agreement calls for a \$2000.00 dollar civil penalty and the issuance of a letter of reprimand.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner Goodmaster and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-275 Canfield Corner Pharmacy

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for failing to maintain the pharmacy premises, in a clean, orderly and sanitary condition. This agreement calls for a \$2000.00 dollar civil penalty.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Beaudin and passed by a vote of 6-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-325 Achorn Pharmacy

Attorney Antonio Santoro presented this case. Commissioner Beaudin 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for: (1) failing to have all pharmacy technicians wear name tags or similar forms of identification clearly identifying them to the public as pharmacy technicians, (2) failing to register pharmacy technicians with the State of Connecticut, (3) failing to complete initial training, (4) failing to assure the continued competency of pharmacy technicians through continuing in-service training designed to supplement initial training, and (5) failing to maintain a written record documenting the initial and continuing training of pharmacy technicians. This agreement calls for a \$5000.00 dollar civil penalty.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Inguanti and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement.

Docket Number 16-326 Switzer's Pharmacy Inc.

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for:

(1) failing to maintain a written record documenting the initial and continuing training of pharmacy technicians,
(2) failing to remove expired front store stock(OTC products),
(3) failed to create a record of every quality assurance review,
(4) failed to maintain a written copy of the quality assurance program on the pharmacy premises,
(5) failed to have a copy of a quality assurance review readily available to all pharmacy personnel and the Department, and
(6) failed to maintain a record of the quality assurance review for all prescription errors for a minimum of three years. This agreement calls for a \$11000.00 dollar civil penalty.

Commission Action: Commissioner Inguanti moved, seconded by Commissioner DeFazio and passed by a vote of 5-0 to accept and approve the aforementioned settlement agreement. Commissioner Goodmaster abstained from the vote.

Docket Number 16-404

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for selling and dispensing controlled substances. This agreement calls for a \$12000.00 dollar civil penalty and the issuance of a letter of reprimand.

Commission Action: Commissioner DeFazio moved, seconded by Commissioner Inguanti and passed by a vote of 5-0 to deny the aforementioned settlement agreement. Commissioner Goodmaster abstained from the vote.

Docket Number 16-406

Attorney Antonio Santoro presented this case. No Commissioner 'stepped down'. This case involved Licensee has been investigated by the Drug Control Division of the Department of Consumer Protection for selling and dispensing controlled substances. This agreement calls for a \$8000.00 dollar civil penalty.

Narcan Dispensing Protocol was discussed and the commission would like to add HIPAA regulations and a remote link to the pharmacy.

2016 MPJE State Specific Review and Pre-test Item Selection Project was completed by Agent Abdelghany, Agent Nasinnyk and Commissioner Inguanti. Over 3000 questions were reviewed in order to keep the Connecticut MPJE question bank current.
