
In addition to providing access to quality dental care, individualized training is offered to all private and public agencies in support of individual's oral hygiene. As DDS Dental Coordinator, I am available to come to your facility, assess the consumers brushing and flossing program and techniques, and provide recommendations and suggestions on how to improve an individual's oral health. I'm also available to meet with nursing staff, caretakers and parent groups to serve as a resource in helping to coordinate dental care. The Department of Developmental Services (DDS) works closely with the Department of Social Services (DSS) and the Connecticut Dental Health Partnership (CDHP) in an effort to expand access to dental care for individuals who receive services from DDS. Connecticut Dental Health Partnership (CDHP) is an organization that administers the dental portion of the Medicaid and HUSKY programs in Connecticut for more than 540,000 residents in Connecticut. The goal of CDHP is to increase the number of individuals receiving dental care under HUSKY/Medicaid coverage. They provide a call center as well as care coordination for their clients. The call center will help with locating a participating dentist, scheduling an appointment and arranging transportation for qualified individuals.

The call center can be reached toll-free at (866) 420-2924 Monday through Friday from 8:00 A.M. – 5:00 P.M. CTDHP is most effective when Medicaid is current and the Medicaid ID number is readily available.

Connecticut Oral Health Initiative (COHI) is a statewide advocacy organization that creates public awareness of the importance of good oral health. Through advocacy, coalition building, and education, COHI works to create a public awareness that should result in better oral health for all.
