I/we acknowledge that the foregoing has been read to me/us and I/we hereby acknowledge receipt of a completed copy of this document.

(2) In consideration of the acceptance of the above order, I/we guarantee payment of the above funeral account and for such additional services and materials as may be ordered by me/us on or before the day of the service or cremation. It is understood that the above guarantee shall not be a waiver of the funeral homes right to present claim against the estate of the deceased. I also agree to pay reasonable collection and/or legal fees in the collection of this funeral bill if it becomes delinquent.

(3) The undersigned further agrees that Alderson-Ford Funeral Homes, Inc. may if it so elects, file a claim for the amount due it on account of the funeral services aforesaid against the estate of said deceased person in any probate court having jurisdiction thereof without in any manner affecting this agreement to pay as herein stated, provided, any monies paid the Company by the estate shall be credited on said account.

(4) This contract contains the entire agreement between the purchaser and Alderson-Ford Funeral Homes, Inc. and supersedes any and all communication representations, undertaking and other agreements, whether oral or written, between them relating to the subject matter of this contract.

(5) I (we) hereby agree to indemnify and hold harmless Alderson-Ford Funeral Homes, Inc., its officers, agents and employees from any claims or causes of action, including a reasonable attorney's fee for the defense thereof arising out of their act of identification or failure to identify, or arising out of their decision to embalm, or not to embalm or arising out of any other decision which may result in mental or physical distress or harm or financial loss to themselves or others.

(6) The contract for services to be performed regarding the above named deceased does not take into consideration the use of jewelry or other items of personal adornment which might have special value and, therefore, it is specifically understood that Alderson-Ford Funeral Homes, Inc. will not be responsible or liable for the loss and will be held harmless therein if the family or party making funeral arrangements requests the use of such items.

(7) That the merchandise in the selection room, books, catalogues, brochures, etc. had the prices clearly indicated thereon.

(8) Authority is granted to transport the remains or cremains of the above deceased via common carrier or postal system. I (we) agree to hold Alderson-Ford Funeral Homes Inc. harmless and to indemnify it or its assigns from any and all claims, demands or damages which may be made or declared against them or their assigns, by reason of transportation of said remains or cremains requested.
