## LIST OF ALL PERMITS AND APPROVALS NEEDED FOR THE PROJECT

### Required Permits and Approvals

The following permits, approvals, and authorizations are expected to be necessary for the development activities at the Hartford Brainard Airport site. Final design details will dictate whether certain permits are necessary. Depending on the final site design, it is anticipated that multiple submissions and applications may be needed in some cases. The timing of submission will vary based on site construction requirements. Some authorizations are specific to construction, and others cover both construction and operations.

1. Connecticut Siting Council petitions and related filings
2. Environmental Justice Public Participation Plan, including a Community Benefits Agreement /Memorandum of Understanding (MOU)
3. Prevention of Significant Deterioration (PSD) Pre-Construction Permit
4. Connecticut Department of Energy and Environmental Protection (DEEP): Compliance with Connecticut Coastal Zone Management Act
5. City of Hartford Zoning Change
6. City of Hartford Site Plan /Flood Plains/Site Plan approval and necessary variances.
7. Soil Erosion and Sediment Control, stormwater management authorizations (City of Hartford Engineering office), and related DEEP approvals, as necessary for both construction and operations
8. United States Army Corps of Engineers (USACE) Individual or Nationwide Permit(s) and Connecticut DEEP Bureau of Water Protection & Land Reuse-Office of Long Island Sound Programs (for stormwater outfall(s) and any shoreline impacts)
9. USACE Jurisdictional Determination (for wetlands)
10. USACE Section 404 Approval (Programmatic General Permit) for construction activities near wetlands as necessary
11. Preparation of United States Coast Guard (USCG) response plan, if needed
12. Federal Aviation Administration notification For Closure
13. City of Hartford construction permitting (electrical, mechanical, plumbing, fire protection, etc.) and various curb/ pavement/ street permits for installation of utilities external to the site, and use of adjoining properties as necessary
14. Well/ boring permits for geotechnical evaluations and remediation-related monitoring wells
15. Risk Management Plan, if applicable

16. City of Hartford Demolition permits
17. Soil disposal authorizations from CT DEEP, if needed
18. Remediation related authorizations/ approvals and Remedial Action Workplan revisions as necessary
19. Potable water supply authorizations and agreements
20. Wastewater discharge to City of Hartford Water Pollution Control Authority authorizations and agreements
21. National Pollutant Discharge Elimination System permit update
22. Spill Prevention Control and Countermeasures Plan updates
23. Additional permits, regulatory updates, or modifications for related activities based on specifics of final design

As noted, the final design may result in changes to this listing associated with the development and construction activities at the Hartford Brainard Airport site. At the current time, and based on the approved conceptual design documents, this listing is representative of the anticipated permitting and regulatory authorizations associated with the Hartford Brainard Airport site projects.
