**I. Call to Order**

**III. Chairman's Report**

Mr. Jack Rosenberg thanked the council members for their time and expertise to work with the CT Office of the Arts. Mr. Rosenberg greeted Mr. Jacob Padron, who although not officially confirmed, has been nominated to serve as council member.

At the request of Mr. Rosenberg, the Governor's Arts Awards committee gave a report on the planning progress for this event. Ms. Sophia Lewitt reported that she has reached out to the awardees to determine a preferred date of either June 2<sup>nd</sup> or June 9<sup>th</sup>, 2022; but has not received a response from all the awardees.

Ms. Elizabeth Shapiro reported that she reached out to the Governor's office to make them aware of this event and the request to have the Governor present; but until the date is determined his commitment to attend cannot be confirmed.

Ms. Judith McElhone stated that Five Points Visual Arts Center is anxious in confirming the date of the event but are ready and excited.

Mr. Rosenberg informed that if needed he has a couple of individuals that he can ask to serve as emcee.

Mr. Rosenberg reopened the conversation of creating a new entity composed of auxiliary members who will serve in an honorary capacity but available to us as a resource. This group should not only be committed to supporting the arts but also advocating for us where they can and with whom they can.

#### **IV. Director's Report**

Ms. Shapiro reported that nominations for the State Poet Laureate opened last week. This is a statutory program. Candidates need to be nominated. Those who have been nominated will be contacted by COA to apprise them of their nomination and then asked to complete an application. The panel review will be conducted in May. Both the State Poet Laureate and the State Troubadour will begin their duties in July, 2022.

Ms. Shapiro also reported that working in alignment with Poetry Out Loud and Poetry Ourselves, both programs are from the National Endowment for the Arts and are held throughout the United States. Staff member, Kolton Harris, manages these programs and has been working to develop a Youth Poet Laureate Program for young people 21 and under.

Ms. Shapiro informed that COA in partnership with the Arts & Business Council of Greater Boston presented last month the first webinar: Legal Entities 101: Legal Entities for Creative Businesses. The webinar was very well attended. The follow up webinar: Legal Entities 102: Charitable Nonprofits will be presented on February 14th, 2022.

Ms. Shapiro also informed that in terms of telework, due to the decline in COVID numbers, Commissioner Lehman has requested that DECD report to work once a week. The arts staff will be in the office on Tuesdays, starting on the week of February 14th.

Ms. Shapiro reported that the art staff continues to meet and work on the Strategic Plan. Staff is very excited on the conversations they are beginning to have and hope that by the beginning of April they will have a frame
