Key Discussions:

Disparity Study:

1. Status Update:

- o The disparity study has been complete since May 2024.
- Key findings confirm long-standing disparities in economic opportunities for Black, Brown, and female entrepreneurs in Connecticut.
- The administration has delayed releasing the study results, citing potential embarrassment over the findings.

2. Next Steps:

- Senator McCrory plans to work with the administration to release the study publicly.
- The findings will be instrumental for crafting targeted equity and inclusion strategies.

Strategic Planning and Target Agencies:

1. High-Value Targets:

- Agencies to engage include:
 - Department of Administrative Services (DAS)
 - Department of Transportation (DOT)
 - Department of Banking
 - Office of Health Strategy
 - Department of Insurance
 - Department of Housing

2. Goals:

- Establish partnerships with these agencies to advocate for equitable opportunities in contracting, employment, and resource allocation.
- Act as a strategic partner (not merely a watchdog) to advance equity initiatives.

3. Action Plan:

- Develop a tentative schedule for engaging target agencies, starting with DAS and DOT.
- Deputy Commissioner Paul Robertson and Avery Gaddis will collaborate to outline a list of agencies and key contacts for future discussions.

Facilitated Conversation:

1. **Preparation**:

- Plans to approve and schedule a facilitated discussion were delayed due to a lack of quorum.
- o An email vote will be conducted to finalize the facilitation process.
- The conversation will include comparisons between the disparity study and prior strategic plans, particularly regarding business participation in various industries.
