#### Observations regarding features characteristic of Olmsted firm design

The Olmsted firm was hired in the 1870s to develop plans for the Connecticut State Capitol Grounds as the site overlooking Bushnell Park was developed based on the relocation of Trinity College. The firm prepared drawings for siting the building, grading, and providing circulation features to access the building.

The property today retains the primary layout as proposed by the Olmsted firm, although parking has been added along the main road leading around the north, west, and south of the building. The oval turnaround south of the building has been removed, while pedestrian paths east of the building have been partially modified. The grades continue to reflect the work completed by the Olmsted firm. Tree plantings may also still survive from the original design.

The State Capitol was sited at the edge of Hartford's Bushnell Park, for which the Olmsted firm consulted on site plans prepared by Jacob Weidenmann, as well as the grounds of the building. The park is the oldest publicly-funded park in the United States. The Olmsted firm devised site plans for the State Capitol Grounds, which replaced the original site of Trinity College, that addressed grading, circulation, layout, and plantings between the late 1870s and mid-1890s.






