# **Connecticut Celebrates Landscape Heritage**

People and organizations around the state are plugging into Olmsted 200, a national celebration promoting designed landscapes, parks, and the benefits of access to nature. This initiative marks the 200<sup>th</sup> anniversary of the birth of Frederick Law Olmsted, a nineteenth-century visionary and founder of American landscape architecture, but expands to topics well beyond the life of one historical figure. A goal of Olmsted 200 is to encourage public and policy commitment to the natural environment and cultural heritage.



FOR ALL PEOPLE Connecticut has a unique association with the Olmsted legacy, as the place of Olmsted's birth, early inspiration, education, and numerous Olmsted firm commissions. We are a state rich with places worth exploring because of the scenic beauty, open space, history, and culture present throughout our communities. SHPO is committed to preserving these places and to create a more robust historic landscape documentation program.

SHPO and Preservation Connecticut are currently working on a joint project to

develop a historical context and survey of Olmsted firm landscapes throughout the state. The results of our work will be available this summer, along with a new landscape survey form. SHPO and Preservation Connecticut will continue to engage in Olmsted 200 this year, by participating in presentations and events, including a celebration at Fulton Park in Waterbury in early October. For over 40 years, Dr. Goodwin served as the President and CEO of R. Christopher Goodwin & Associates, a cultural resources firm based in the Washington D.C. area.

The state of Connecticut is indebted to Dr. Goodwin and his team for their commitment to documenting the state's historic resources in



the aftermath of Super Storm Sandy. Under Dr. Goodwin's leadership, Goodwin & Associates worked for over 4 years to prepare numerous **National Register nominations**, **surveys**, and most notably, shedding light on the state's **underwater shipwrecks** and other **archaeological sites** impacted by climate change.

A new exhibit about Guilford architecture is now on display at the Henry Whitfield State Museum. On Ioan from the Guilford Keeping Society, "Weld-Built: The Guilford Architecture of William E.
